

History of the Unitarian Universalist Village Church

Milestones

- 1965 organized as Hot Springs Unitarian Universalist Fellowship.
- 1996 moved to Hot Springs Village and renamed Unitarian Universalist Village Church.
- 2010 purchased church building at 403 Barcelona Road and moved in February 2011.
- 2016 Rev. David Ruffin served as Developmental Minister, August – February.
- 2017 Rev. Mark Walz became half-time Minister of UUVC in August.
- 2019 Rev. Walz was installed as settled Minister in May.

Overview

1. Organized in 1965 as a Unitarian Universalist Fellowship, (later renamed Church) and chartered with the UUA, the congregation met in Hot Springs in various locations twice a month from September to May on the first and third Sundays. The membership was as few as 10 some years.
2. In 1990, a discussion group was organized in Hot Springs Village, meeting twice a month during the week.
3. As Hot Springs Village grew, the number of church members living in the Village increased and a larger meeting space was needed.
4. In 1996 the members voted to begin holding services in Hot Springs Village, in rented facilities in the Coronado Center. A few of the members who lived in Hot Springs did not want to move and started a new congregation there.
5. In January 1997, the name was changed to the Unitarian Universalist Village Church. The membership was 27.
6. In 1999 the discussion meetings were moved to Sunday and renamed Insight, so that the congregation met every Sunday from September until May or early June.
7. The membership grew slowly for several years, doubled in size during 2005-2007 and was 73 by 2010.
8. In 2010, the members voted to buy the building owned by the Village Church of Christ and moved into the building on February 19, 2011.
9. Rev. David Ruffin served as a part-time developmental minister from August 2016 to February 2017, when he resigned for personal reasons.
10. In August 2017 Rev. Mark Walz became UUVC's half-time minister and was installed as called minister on May 8, 2019.

From 1965 to 1996

On October 10, 1965, at the Convention Auditorium in Hot Springs, sixteen Hot Springs citizens gathered to organize the Hot Springs Unitarian Universalist Fellowship which was then chartered with the Unitarian Universalist Association. The leader was DeVere Dierks Jr. Dierks was from a well-known family and the Executive VP of the family lumber corporation (which later became Weyerhaeuser). In August of 1967 he was killed in an automobile accident. Funeral services at Westminster Presbyterian Church

were attended by Gov. Rockefeller and many other notables. Dierk's dream of building a home for the UU church died with him.

The HSUU Church, like many small societies in the Southwest, never had a full-time minister. Harold Marley, a retired UU minister who had been one of the signers of the original Humanist Manifesto, guided the young church as a volunteer for several years. The congregation grew to 28 after one year, but during the '80s and early '90s the membership was between 10 and 15. The congregation met twice a month and held services at many locations, including the Hot Springs Holiday Inn, the Convention Center, YWCA, the Hot Springs Art Center, House of Israel Synagogue, the Bridge House, the bar at the Quality Inn, and The Art Foundation. In the early years, the times of the services were adjusted so members could attend other services before or after the UU service.

By 1982 the Fellowship consisted mostly of politically conservative older people and singles though there were a few children in later years. Services twice a month were a sermonette followed by discussion. The topics of services ranged from other religions to the lives of famous Unitarians. In the late 80s it was decided to assume the designation of "Church," meeting national guidelines, rather than "Fellowship," but there was no increase in membership. The most significant change came about when people from Hot Springs Village began to attend, starting in the late 80s. By the spring of 1995, 22 of the 30 members lived in Hot Springs Village. They were largely politically liberal. The services gradually became more formal, and by 1995 included a chalice lighting, printed order of service and a choir, in addition to a speaker.

In 1995, Joe Groseclose started a fund to buy something for the new Garland County Library, with a promise to match funds raised. A children's kiosk was purchased for about \$3500 and installed there, with a brass plaque identifying that it was a gift from the church. The group also occasionally took up collections of food for Jackson House and had a Birthday program for a mental health residence. While meeting at the Arts Center, there was financial support of that organization. A Growth Fund was started in 1995, to be used only for a minister or a building.

Except for sending three persons to the UUA General Assembly in Little Rock in 1987, there was little involvement in the larger denomination in the early days. Meg Koziar attended the UUA General Assembly in 1994, and she and Billy Jane McIntosh attended a District meeting.

In 1990, a discussion group was organized in the Village by Margaret Perritt and Ruth Knox. They met twice a month, on Thursday afternoons, in members' homes. Eventually the group grew too large for homes and started meeting in the Good Samaritan Cedar Lodge library.

1996-1997 Move to Hot Springs Village

The group had been meeting in the gallery of the artist Benini (The Art Foundation) since January of 1993. By 1995 it was outgrowing the facility and there were concerns about the security of the valuable art. During the next year, a committee looked extensively, but unsuccessfully, for a new meeting place. In August 1996, a congregational meeting was held in Hot Springs Village at the home of Alan and Linda Scott, with all the members present except one Hot Springs resident, with new President, Sigrid Rowin, presiding. A motion was made to move the services to rented facilities in Hot Springs Village. The motion carried unanimously, except for one Hot Springs resident who abstained. By the next week, however, several members in Hot Springs got together to start meeting on their own. The UUA District Director tried unsuccessfully to get them to stay as one congregation meeting on different Sundays. The congregation in the Village, including several people who lived in Hot Springs, continued as the Unitarian Universalist Church of Hot Springs until January of 1997, when it was voted to change the name to Unitarian Universalist Village Church. It was considered by the UUA to be the chartered congregation and the one in Hot Springs a new congregation.

- Meetings were held in room 6 of the Coronado Center at 10 a.m. on the first and third Sundays, September to May.
- The Discussion Group continued to meet at the Good Samaritan Lodge Library on the 2nd and 4th Thursdays, at 4 p.m. Several people from other churches were regular attendees.
- After a committee, chaired by Allan Scott, researched various charities to support, Jackson House Crisis Center in Hot Springs was chosen. The church collected winter clothing and blankets from the community for Jackson House in

a November "Thanks for Giving" drive, and volunteers started preparing lunches at Jackson House once a month.

- Small Group Dinners were started.
- Portable Church signs were purchased, with funds from UU Southwest District Chalice Lighter grant of \$200, to place in front of the meeting place door, and at the corner of the main road on Sundays
- The Annual meeting was held in May at the Cortez Pavilion, followed by a picnic.

- Enough Funds were raised by members' contributions during July to add to the Growth Fund to make the down payment of \$150,000 for purchasing the building at 403 Barcelona Road from the Village Church of Christ. The purchase was final on July 31. VCC rented the building from us until their building was completed, but UUVC was able to use it for special events and Board meetings. They moved out and UUVC moved in in February 2011.
- The Village Church of Christ held the mortgage at 4%, with interest-only payments and principle payments of \$20,000 due 12/12 and \$10,000 due 7/15. The remaining to be paid over the last 15 years.
- A Building Transition ad hoc committee operated until a Building Committee was added to the board in February.
- UUVC took over the Computers for Kids program that began in the Fountain Lake Schools by Bob McCleskey. Beth Zabel took the lead in the program and expanded it to other local school districts, starting with Mountain Pine Schools.
- A Neighborhood Network was organized by Lee Duckfield for Care and Concern. Each of five neighborhoods in the Village had a coordinator who could be called in case of illness or other need.
- UUVC formally sponsored Rev. Bud Hearn's six-week seminars. They were held three times a year for on a weekday in the Community Hall. He also presented a one-day workshop for the congregation "Becoming a More Inviting Congregation."
- UUVC participated in the Green Leader Certification Program sponsored by the Garland County Beautification Commission and received Silver Certification.
- A joint Service with the Hot Springs UU Church was held at their church in November, followed by a Thanksgiving potluck, and another in April in our new building with Rev. Mark Walz as the speaker, followed by an Easter potluck.
- A party was held to honor Don Stiles' 100th birthday, but he was not able to attend.
- Volunteers began working at the Jackson House Thrift shop once a month.
- A book fair was held in December, with proceeds to the Building Fund.
- A collection of blankets and winter clothing was given to the Oaklawn migrant workers.
- Singing meditation services were held before Insight services from January through May.
- Delfin Bautista, UUA's LGBT Ministries Program Coordinator was a speaker.

- February 12 was move-in day to 403 Barcelona Rd, and the first Insight service was held on February 13, with Dr. Alan Ward the speaker.
- Congregational Conversations took place on Saturdays.
- Woodworkers in the congregation constructed a sign (Ed Bayer), a chalice emblem for the front of the sanctuary (Ed), a chalice table (Jay Williams), and a lectern.
- A Conflict Resolution Policy was adopted in February.
- Outside groups using the building were AAUW, who rented space for their book sorting and sale, Sewing for Orphans in Tanzania, and groups with one-day events.
- The library, finally having a permanent home, was expanded and expertly cataloged by Carl Ford.
- The Art Group AIG put up a display of congregants' art in the Community Hall, and Members and Friends loaned or donated art for the rest of the building.
- An election was held in April with, for the first time, more than one nominee for President and VP, and a paper ballot. Nominees for president presented their goals in speeches to the congregation.
- Rev. Mark Walz and his wife gave the congregation 7 banners of the UU Principles.
- A tornado came through the Village in April with extensive damage to some members' homes, but not to the church.
- UUA Southwest District Director Susan Smith taught "UU 101" on May 21. A building dedication was held on May 22, with Susan Smith, Rev. Bud Hearn and Rev. Pati Trippel conducting the service. Invitations were sent to other churches and 130 people attended. A formal reception was held after the service.
- Following suggestions that UUVC hold Worship services every Sunday, it was voted at a congregational meeting that the membership must approve any changes in Sunday morning programming, and to continue having Sunday programs through the summer for the first time.
- A new website was developed, replacing the internal and external sites.
- An AED (defibrillator) was purchased for \$1500 of which \$1000 was donated.
- Nametags with lanyard cords were first used.
- A used Baby Grand piano was purchased.
- Recycling boxes were placed in the church by the Social Action Committee for newspapers, aluminum cans, white paper, batteries, and ink cartridges.

- UUVC was accepted as a Red Cross Daytime Emergency Shelter.
- A Wayside Pulpit was investigated, but POA regulations made it impractical, so inspirational quotes were placed inside the church.
- A meditation group lead by Quay O'Hara met for several months.
- Jerry Offerman agreed to produce a painting representing UUVC Values. The painting was dedicated on February 14 and placed in the entrance lobby, along with an explanation. - An ADA compliant ramp was constructed at the south door to the Community Hall.
- A team again participated in Keep HSV Beautiful Clean-up efforts.
- Sunday Conversations resumed by Zoom at 11:15, preceded by "Coffee Time" at 11:00. On Worship Sundays Rev. Walz led the conversation, and most Insight speakers were on the Zoom call on Insight Sundays.
- Starting in November, a Keep In Touch Team,(KITT) assembled gift bags and delivered them to every member and friend. Headgear appropriate to the occasion was worn by the team, (Turkey trotters, Elves, etc.) The bag included a card with instruction for the use of the items, and photos were taken of many recipients holding a "We love UUVC" sign.
- In lieu of our usual Christmas Eve Soup Supper, a collection of soup recipes of members and friends was put on the website.
- A Spiritual Practices class starting in January and originally scheduled for a few weeks was so popular it continued all year .
- Articulating Your UU Faith completed the interrupted in-person class by Zoom.
- A Humanism Discussion group was formed and met monthly beginning in January.
- A Book-Sharing discussion with Rev. Walz began in February.
- A special presentation by Elmer Beard, a black leader from Hot Springs took place in February by Zoom.
- The Culinary Green Team produced a cooking lesson by Zoom in February and another in July.
- Pipes in the ceiling over the library froze during an extreme cold snap in February and flooded the entire sanctuary lobby area, requiring extensive repair. Insurance covered most of the cost, but the result was that the area was closed to use until the end of the church year.
- Other building update included new globes in the sanctuary.
- A new website design was planned by a task force starting in August, and the congregation voted to fund it, but the plans to put it into place fell through due to illness in the company chosen to put it into effect.
- At the request of the Social Justice Committee, the church joined the Citizen First Congress to work toward progressive legislation in Arkansas. 56 members and friends responded to a Social Justice Inventory, and many contacted legislators during a hectic AR legislative session.
- A number of members attended a peace vigil sponsored by the NAACP in June.
- The building was reopened for small group meetings, with COVID-19 precautions, on April 24.
- The Annual Meeting was held by Zoom, and voting for Board members, the budget, and a minor revision to the bylaws done by email with 90 members voting.
